

Management change at the KraussMaffei Group as of 10 January 2024

- Former Chairman of the Supervisory Board Chi Zhang takes over the position of Chief Executive Officer (CEO)
- Former CEO Yong Li becomes Chief Administrative Officer
- Vice President of Sinochem Holdings Corporation
 Shihao Yang takes over the position of Chairman of the Supervisory Board

(Munich, 12 January 2024) - The Supervisory Board of the KraussMaffei Group (KMG) has reorganized the management of the Group. The previous Chairman of the Supervisory Board, Chi Zhang, has been appointed as the new Chief Executive Officer (CEO) with effect from January 10, 2024. The previous CEO, Yong Li, will take on the newly created position of Chief Administrative Officer. His responsibilities will include Corporate HR, IT and Audit. Shihao Yang from the top management of KraussMaffei's main shareholder Sinochem will head the Supervisory Board. The change will be accompanied by a significant strengthening of the KraussMaffei Group's Management Board, which will be increased to three members. Jörg Bremer remains a member of the Management Board as Chief Financial Officer.

The new CEO Chi Zhang has been with Sinochem for more than two decades in a variety of executive, operational and project-related management positions. Since the end of 2022, he has been the Chairman of China National Chemical Equipment Company (CNCE), a Sinochem Holdings company and owner of the KraussMaffei Group.

Chi Zhang said of his new position as CEO: "I am very much looking forward to this new role. With our new, further strengthened management team, the

I am very pleased that Yong Li will continue to be available to KraussMaffei in the new position as Chief Administrative Officer. I will work together with members of Supervisory Board and Management Board to make KraussMaffei shine again."

The previous CEO and current Chief Administrative Officer, Yong Li, says: "The past year has been very challenging, but with the strong commitment and dedicated efforts of our team we have made some good progress. I would like to thank Jörg Bremer and our colleagues for their contribution towards the turnaround. There is still a lot to be done to reach our target and we will keep moving forward. I will continue to give my best to KraussMaffei and I am looking forward to working with the expanded Management Board under the leadership of Chi Zhang."
